Inside Prison Program, continued.

During 2022 LTTL ministered to over 15,000 inmates resulting in many lives being changed and strengthened. The Rehabilitations Program Division approved the Starting Point Discipleship Program which helps new believers navigate topics such as "What is Faith?" and "Knowing Who You Are In Christ" and is being offered at four prison units. A second discipleship program is being developed; its purpose is helping new believers overcome the struggles and trials of everyday life. As tangible evidence of God's love and in partnership with unit chaplains, LTTL also provides free hygiene supplies (soap, toothpaste, deodorant, and shampoo) to inmates who cannot afford to buy them from the unit commissary.

Outside the Walls Program, continued.

During prison chapel services, inmates enter their prayer requests on Prayers And Letters (PAL) forms so that LTTL's outside volunteers can join them in prayer. Each inmate then receives a written response to their prayer request.

One study Bible is mailed free of charge to inmates who request them.

Clothing is also donated through the prison chaplains for inmates to wear as they leave prison. Ex-offenders experience challenges when returning to society and LTTL offer emergency assistance on a case-by-case basis.

Due to the nature of prison ministry and the use of the chapel's audio and video equipment for the various worship services and classes every day of the week, this equipment must be replaced or upgraded more often than is experienced at free world churches.

In 2022, at the Mark W. Stiles Unit in Beaumont, a new mixer board was provided to replace the old one that had some non-functioning channels. After installing the new mixer at Stiles, LTTL recommended and facilitated the transfer of the old board to the Plane State unit in Dayton to replace a smaller mixer. The old Stiles mixer had more than enough channels to meet the need at Plane State. Thus, one donation benefited two prison units.
